**Cem 16/12 Apologies for absence –** Apologies were received and accepted from Cllr J. Searle

Cem 16/13 Minutes – Resolved Clerk authorized to amend the minutes of the meeting held on 19<sup>th</sup> October 2016 previously circulated. Following consultation regarding the future planting of trees in the new Woodland Burial plots, as the marker posts are to be in the centre of the burial plots, members agreed there would be 1 tree at the head of each double burial plot after the final burial (unless cremated remains) Chairman signed the minutes as a correct record.

# Cem 16/14 Appointment of Cemetery Caretaker/grounds man-Resolved

- i) Members noted the new Cemetery Grounds man, Michael Frost had been appointed starting week 1<sup>st</sup> February 2017.
- ii) Members considered Saturday burials/Bank Holiday/Weekend Working **Resolved –** No burials would take place in future over the weekend. Clerk to amend the Cemetery Regulations and inform the local under takers.

# Cem 16/15 Cemetery Maintenance - Resolved -

- i) Chapel Decoration Clerk to meet with members to consider if decoration required in 2017. Proposed date 12<sup>th</sup> April 10.00 at Cemetery
- ii) Cemetery Fees Charges are due for review **Resolved** Clerk to seek comparisons and discuss and changes with Chairman for approval at the Full Council Meeting prior to 1<sup>st</sup> May 2017.

### Cem 16/16 Woodland Burial Ground -

i) Mapping the 2<sup>nd</sup> section of Woodland Burial area -**Resolved** - Chairman to meet with

Clerk in April to discuss availability of land space for future burials in new sections. Mapping to be considered after this date towards the end of June.

- iv) **New bund in Woodland** Members considered a request to the Finance Committee **Resolved** Clerk to speak with the new grounds man prior to the October meeting for his view regarding a suitable location. It was agreed that this would be necessary in the future and it would be preferable to locate a new bund adjacent to the access lane to allow for ease of access for emptying.

- i) **Tree Maintenance –** Northern Tree Services have completed the work requested to the 3 trees highlighted at the walkabout, at a cost of £875.
- ii) Tree Maintenance adjacent to Summerfield to rear of chapel Northern Tree services have been asked to survey and report back with quote for any required work.

- i) To have a 5 Year Plan with a review of the existing woodland trees to be undertaken 2019/20.
- ii) Clerk advised members of the use of burial orbs as a way of marking plots, this was deferred until the next meeting to consider the alternatives.
- iii) Deferred consideration of using a student to locate and mark existing plots in Woodland, with stakes.
