(ii) Growing concerns over the development of Rural Areas (Written by Cllr N Holmes)

Members supported the concept of "new rural villages" in the right location with appropriate infrastructure.

(iii) Skelton House, Wetheral, update following recent correspondence from Wetheral residents.

Resolved to request a meeting with Jane Meek, Director of Economic Development, Carlisle City Council to discuss the current issues, how to prevent a similar occurrences in the future and proposed developments in the Parish, this discussion would include the concept of new villages.
