It was stated at the meeting that it would be difficult to have a NP for one or two villages, it would be required to cover the whole Parish.

ii) <u>Resolved</u> to support Neighbourhood plan steering group with a Cllr representative from each ward and two residents from each settlement. This may require office resources on a limited basis.

### 82/17 External Representation

**Resolved** to receive reports from Parish Council representatives on outside bodies.

- i) Cllr Hughes-Scotby Pavilion Steering group meeting held on Wednesday 27<sup>th</sup> September 2017-Planning permission has been granted, the proposed build would be timber framed which is built off site, this reduces the need for construction traffic and reduce the build time. (Clerk to check with the insurers regarding the fabric of the building)
- ii) Cllr Hughes -Scotby Village Hall meeting; completely new committee, review of fees & charges undertaken.

- iii) Cllr Higginbotham-Down-a-Gate AGM, 30 in attendance, the centre planned to be complete Feb/March 2018. Shortfall of £10k for the construction and £10k for the tarmac. Further funding sought. The number of committee members has reduced to 9, they require 12. Legal advice has been taken, only 2 representatives are required, the committee are happy with the 2 Wetheral Parish Councils reps. Next meeting November 6<sup>th</sup>TBC.
