All were invited to the Harvest Gathering on Sunday 7<sup>th</sup> October @ 4.00pm- A Farmers Story. PCSO Tom Haworth is our liaison with the Police covering Wetheral Parish and outlying area. He will be arranging Police desks in the local villages to allow residents to speak to a Police officer directly in the near future.

Issues in Wetheral this summer included fires on the river bank, youths and litter on the village green. Members thanked him and his colleagues for dealing with the youths.

Issues raised with the PCSO – concerns regarding the issues with the traffic lights B6263; potential accident when they fail. Speeding in the villages.
