**PL/14/91 Declarations of Interest** - Cllr Earp declared an interest as a member of Carlisle City Council. Cllr Bainbridge declared an interest in item 7(iv) As a neighbour of the access track. Cllr Higgs declared an interest in item 7 (iii) as a neighbour of applicant.

**PL/14/92 Public Participation** - Residents of Wetheral representing the Save Wetheral Group, requested support from the Parish Council, with reference to the recent Decision to Refuse Permission for the amendments to the Application 15/0028. Council was advised that the application was retrospective and that the balconies were in the process of being installed. Council was requested to ask for their removal. Chairman thanked residents and advised that as the decision was only made 3 days previously it was felt the situation should be monitored to give the developer time to act upon the order. It was agreed to place the item on the agenda for the next Planning Committee meeting.

## 15/0186 Land to north of Thornedge, Cumwhinton

Erection of Stables, Tack Room and Food Stores

#### Observations

Whilst members did not have any objections they had several comments they wish to be considered:-

- i) Public Footpath (N.B. not shown on plans): It was felt that the existing access track is poorly maintained and unsuitable for purpose at present, any increase in traffic in particular agricultural vehicles would make this worse. Although the developer has agreed to gravel the track, which met with approval, it was felt that the field drains needed attention if this problem was to be alleviated.
- **ii)** Access Concerns were raised regarding the access of traffic entering and exiting the track from the Scotby/ Cumwhinton road, where there was no speed limit in place.
- **iii) Stables** The stables application is retrospective, as it would appear they have already been moved. The roof shown on plans is "green" **not** as in position.

Members would have preferred to see the stables situated farther away from the proposed new housing development in view of any smell or noise.
