# WETHERAL PARISH COUNCIL PLANNING COMMITTEE MINUTES OF THE MEETING HELD on Monday 1st October 2018 At 1pm at Wetheral Village Hall

i) Cllr Earp declared an interest as a member of Carlisle City Council, Development Control Committee.

# PL/18/36 Public Participation

The applicant for 18/0806 (Wetheral Abbey Farm) attended the meeting. He described the current state of disrepair of the property, including dry rot, and assured the committee that he plans to carry out a sympathetic restoration, keeping as many original features as possible. A flood risk assessment will be carried out and the Heritage Officer has been invited to view the property. The outbuildings will be used to store vehicles and equipment, and the family will be keeping their own horses at the site. The farmhouse will be a family home. Access for the work will be via the playing field end of the Abbey Road, not through the village. A 20mph speed restriction for works vehicles will be put in place by the applicant.

Cllr Evans asked if there were any plans for a commercial equestrian business. The applicant said there will be a maximum of three horses, all belonging to the family. Cllr Earp queried the addition of Velux windows, and windows and large doors in the single storey extension. The applicant said the roadside windows will be almost invisible and he plans to use conservation Velux to make the appearance as unobtrusive as possible. The Heritage Officer has said the addition of the doors needs to be discussed. A site historian has said they could be considered as progressive change over time. Cllr Earp asked if the applicant would be willing to tidy up the sandstone water trough opposite the property. The applicant confirmed that this would not be a problem. Cllr Poole commented that the applicant has carried out a high-quality, sympathetic restoration to his current property in the Parish.
